## Minutes

Chairwoman Mary Wood called for a motion to approve the minutes for October 2024 meeting. Lucille Walker made a motion to approve the minutes and Delegate Gary Simmons seconded.

# **Director's Report**

RAC Update: St. Mary's County and the TCC Exec Board has concluded that despite best efforts, the RAC project can go no further in its current state. The only way to achieve success is moving forward and pivot from the current model and current MOU. The TCC Exec Board and St. Mary's County will come to a mutual amiable agreement on how to dissolve the partnership, the MOU, and the current project, at the next TCC Exec Meeting on Nov 21st. Pending that official dissolution, SMADC will be returned a portion of the money that was given to St. Mary's for the project (approx. \$300,000 - \$500,000 depending on how the contract is dissolved.)

#### The Motion is as stated:

"Re-allocate funds in the amount of 500k for the RAC MOU for a public/private partnership for a meat processing facility and if approved by the TCC Executive Board, TCC move to dissolve the agreement with St. Mary's County with the transfer of ownership of the RAC building plans to SMADC.

Furthermore, SMADC agrees to the negotiations by TCC for the cancellations of the MOU for the RAC in St. Mary's County. "

The vote was 14 members stating aye and one abstaining.

### **SoMD Community Fridges and Food Access:**

The SMADC MMM/Food Access Team is proud to announce an exciting collaboration with the Maryland Department of Agriculture (MDA), several local farmers, and Maryland watermen to bring free, locally grown Thanksgiving Boxes to families in need. This initiative, made possible by a grant from the Charles County Board of Commissioners, will feature 100% Maryland-grown turkeys and produce. The boxes will be distributed at a special giveaway event on Friday, November 22nd, at LifeStream Church of the Nazarene in Waldorf, MD (5105 Leonardtown Rd, Waldorf, MD 20601). This effort is part of a broader campaign by Maryland's Best to highlight organizations providing access to locally sourced, nutritious food during the holiday season.

#### **Funding Appeal:**

#### **Outreach:**

We are pleased to announce the placement of multiple billboards around the SOMD region advertising our Farms for the Holiday Guide that features over 100 farms & agricultural producers and their goods for the holiday season! This was funded by the USDA FMPP grant, via the marketing and promotion portion.

#### **Regulatory:**

SMADC continues to act as a liaison between Amish/Mennonite Communities and the Maryland Department of Health. One Amish farmer has been waiting patiently to hear an update on the law requiring the cottage food producers to provide an email and phone number on the label of their products to be sold at a grocery store be changed to allow a representing entity to be labeled on their product. This farmer has been waiting since April 2024. SMADC was informed that the MDH had been reviewing that change and was informed there may be an emergency regulation change to allow a representing entity to be the point of contact on the label. In late October, SMADC was sent a letter via Senator Jack Bailey from the MDH stating "This regulatory proposal will be prepared and sent to the Joint Committee on Administrative, Executive, and

Legislative Review (AELR) for review before it is sent to be printed in the Maryland Register. MDH anticipates sending this proposal to AELR prior to the upcoming regulatory
